Entry Requirements:

- All paintings must be original and must comply with the Criteria for Artwork.
- Each artist may enter one piece.
- The maximum image size is 24" x 30" or a total of 720 sq. inches
- No entry may be from an earlier exhibit or workshop.
- All submissions must be odor-free and dry.
- Submittals of sculpture, fabric art, photography, computer generated art, combines and/or assemblages, giclee printing forms, and any artwork that is not amenable to hanging on a wall are excluded from this exhibit.
- DO NOT REMOVE PAINTINGS without notifying a show co-chair.

SRAL reserves the right to disqualify any entry, upon arrival, that does not meet the above requirements.

Categories: Representational and Non-Representational

- Artist, you will need to select which category best fits your artwork.
- No category changes are allowed after the entries have been received.

Delivery Requirements:

- Paintings must have the artist's name, title of the painting, and phone number on their backs.
- The ends of the wires must be wrapped with masking tape, unless coated wire is used, to avoid injuries to the hanging crew.
- All entries can be accompanied by a bio or resume to be delivered when you bring your artwork.
