**ENTRY FORM & REQUIREMENTS**

The purpose of the Masters Show is to recreate a painting as closely as possible to the original of an artist that you consider to be a “Master.” This would include color, technique, form, brushstrokes, etc. It is not necessary for your reproduction to be the same size or done in the same medium as the original. ALL SRAL FRAMING GUIDELINES MUST BE FOLLOWED.

**Two entries maximum.** No entry fees. Judging will be done by the artists who have entered the show. Artist’s Choice ribbons will be awarded.

**\*DUE TO UNITED STATES COPYRIGHT LAWS, WHICH SRAL ENFORCES, THE ARTIST THAT YOU SELECT MUST HAVE BEEN DECEASED SINCE AT LEAST 1955 (70 YEARS).**

**Entry Requirements:**

- All entrants must be **current SRAL members.**
- All paintings must comply with the **Criteria for Artwork** ([Click Here](#)).
- Each artist may enter up to two pieces. There is no entry fee.
- There is no size limit but keep the dimensions reasonable.
- No entry may be from an earlier exhibit or from a workshop.
- All submissions must be odor-free and dry.
- Submittals of sculpture, fabric art, photography, computer generated art, combines and/or assemblages, giclee printing forms, and any artwork that is not amenable to hanging on a wall are excluded from this exhibit.
- **DO NOT REMOVE PAINTINGS** without notifying a show co-chair.

SRAL reserves the right to disqualify any entry, upon arrival, that does not meet the above requirements.

**Delivery Requirements:**

- Paintings must have the artist’s name, title of the painting, and phone number on their backs.
- The ends of the wires must be wrapped with masking tape, unless coated wire is used, to avoid injuries to the hanging crew.
- All entries may be accompanied by a bio or resume to be delivered when you bring your artwork.

**Entry Form Deadline:** Postmark no later than **Saturday, February 8, 2025.**

**Art Due for Hanging:** Sunday, February 16, 2025, from 10:00 – 11:00 AM.

**Reception date:** TBD

**Art to be picked up:** Monday, March 31, 2025, from 10:00 – 11:00 AM.

**Location:** West Center

**Prizes:** Artist Choice Ribbons
